IN ADDITION TO THE PROVISIONS CONTAINED IN THE RIDER, THIS ADDENDUM MAY PERMIT THE BORROWER TO CONVERT THE ADJUSTABLE RATE LOAN INTO A FIXED RATE, LEVEL PAYMENT, FULLY AMORTIZING LOAN, SUBJECT TO SATISFACTION OF CERTAIN CONDITIONS.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument and the Rider, Borrower and Lender further covenant and agree as follows:

(A) OPTION TO CONVERT TO FIXED RATE

If I choose to make the conversion option, I must give the Lender notice that I am doing so at least 30 days before the next Conversion Date (the "Effective Conversion Date"). I also must sign and give to the Lender the documents, in any form that the Lender may require, changing the terms of the Note to give effect to the conversion. Beginning with the Effective Conversion Date, if such conversion has been chosen, my new fixed interest rate will be equal to the Federal Home Loan Mortgage Corporation's published required Net Yield for 30-year, fixed rate mortgages covered by 60-day mandatory delivery commitments in force on the Effective Conversion Date, plus three-eights of one percent (. 375 %). If such required Net Yield is not available, Lender will determine my interest rate by using a comparable figure.

I will pay the Lender a conversion fee equal to one percent (1.0%) of unpaid principal as of the Effective Conversion Date. I will pay the conversion fee on or before the date of my first monthly payment after the Effective Conversion Date.
