## 2.12 Mortgagor to Pay the Note on Any Default in Payment: Application of Monies by Mortgagee.

- (a) If default shall be made in the payment of any amount due under the Note, this Hortgage or any other instrument securing the Note, then, upon Mortgagee's demand, Hortgagor will pay to Mortgagee the whole amount due and payable under the Note and all other sums secured hereby; and if Hortgagor shall fail to pay the same forthwith upon such demand, Mortgagee shall be entitled to sue for and to recover judgment for the whole amount so due and unpaid together with costs and expenses including the reasonable compensation, expenses and disbursements of Hortgagee's agents and attorneys incurred in connection with such suit and any appeal in connection therewith, Hortgagee shall be entitled to sue and recover judgment as aforesaid either before, after or during the pendancy of any proceedings for the enforcement of this Mortgage, and the right of Hortgagee to recover such judgment shall not be affected by any taking, possession or foreclosure sale hereunder, or by the exercise of any other right, power or remedy for the enforcement of the terms of this Hortgage, or the foreclosure of the lien hereof.
- (b) In case of a foreclosure sale of all or any part of the Mortgaged Property and of the application of the proceeds of sale to the payment of the sums secured hereby, Mortgagee shall be entitled to enforce payment of and to receive all amounts then remaining due and unpaid and to recover judgment for any portion thereof remaining unpaid, with interest.
- (c) Mortgagor hereby agrees, to the extent permitted by law, that no recovery of any such judgment by Hortgagee and no attachment or levy of any execution upon any of the Mortgaged Property or any other property shall in any way affect the lien of this Hortgage upon the Hortgaged Property or any part thereof or any lien, rights, powers or remedies of Hortgagee hereunder, but such lien, rights, powers and remedies shall continue unimpaired as before.
- (d) Any monies collected or received by Mortgagee under this Paragraph 2.12 shall be applied as follows:
  - (i) <u>First</u> to the payment of reasonable compensation, expenses and disbursements of the agents and attorneys;
  - (ii) <u>Second</u>, to payment of amounts due and unpaid under the Note, this Mortgage and all other instruments securing the Note.
- 2.13 Delay or Omission No Waiver. No delay or omission of Hortgagee or of any holder of the Note to exercise any right, power or remedy accruing upon any Event of Default shall exhaust or inpair any such right, power or remedy or shall be construed to waive any such Event of Default or to constitute acquiescence therein. Every right, power and remedy given to Hortgagee may be exercised from time to time and as often as may be deemed expedient by Hortgagee.
- 2.14 No Waiver of One Default to Affect Another. No waiver of any Event of Default hereunder shall extend to or affect any subsequent or any other Event of Default then existing, or impair any rights, powers or remedies consequent thereon. If Kortgagee (a) grants forebearance or an extension of time for the payment of any sums secured hereby; (b) takes other or additional security for the payment thereof; (c) waivers or does not exercise any right granted in the Note, this Mortgage or any other instrument securing the Note; (d) releases any part of the Mortgaged Property from the lien of this Mortgage or any other instrument securing the Note; (e) consents to the filing of any map, plat or replat of the Land; (f) consents to the granting of any easement on the Land; or (g) makes or consents to any agreement changing the terms of this Hortgage or subordinating the lien or any charge hereof, no such act or omission shall release, discharge, modify, change or affect the original liability under the Note, this Mortgage or otherwise of Mortgagor, or any subsequent purchaser of the Mortgaged Property or any part thereof or any maker, cosigner, endorser, surety or guarantor. No such act or omission shall preclude Mortgagee from exercising any right, power or privilege herein granted or intended to be granted in case of any Event of Default then exist-
