KNOW ALL MEN BY THESE PRESENTS, That I, Olivia A. Moore of Greenville County

in the State aforesaid
in consideration of the sum of Two hundred (\$200.00) Dollars,
to me in hand paid at and before the sealing of these presents by

H.M. Moore (the receipt whereof is hereby
acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

H.M. Moore all that certain piece, parcel and tract of land situate, lying and being in the
County aforesaid and having the following metes, bounds and distances to wit:
Beginning at the mouth of Smith Branch; thence S. 17 W. 21.75 links along H.M. Moores land to a
stone; thence N. 29 W. 18.98 links to a stone on Stony Creek; thence along said Creek N. 67-1/2 E.
5.54 links to a Maple; thence along said Creek N. 65 E. 4.42 links to a W.O.; thence said Creek
N. 48-1/2 E. 3.40 links to a stone; thence along said Creek S. 75-1/2 E. 3.50 links to the beginning
corner, containing 13 acres and being part of tract No. 4. of my Father's real-estate and conveyed
to me by W.B. Moore by a deed bearing date May 4, 1903 and recorded in R.M.C. office of Greenville
County in Volume J.J.J. page 624.
