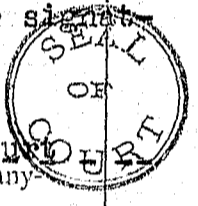
KNOW ALL MEN BY THESE PRESENTS, That I, Mary E. Decamps of Greenville County

M.H. and W.J. Goodlett (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

M.H. and W.J. Goodlett, share and share alike, the following described lots of land to wit: Lot No. 1- Beginning at a 3X on the West side of DeCamp Street and 3X of Mrs. Runion and Mrs- DeCamps lots and running; thence with said Street N. 13-50 E. 59' to a 3X on said Street and also 3X of lot No. 2; thence N. 72 W. 95.3' to a 3X on back line; thence with back line S. 19 W. 48.5' to a 3X; thence S. 66 E. 101' to the beginning 3X. Lot No. 2- Beginning at 3X of lots No. 1 & 2 on the West side of DeCamp Street and running; thence with said Street N. 13-50 E. 49.5' to a 3X on said Street and 3X of lot No. 3; thence N. 72-35 W. 91.3' to a 3X on back line; thence with back lines S. 19 W. 48' to 3X also 3X of lot No. 1; thence with line of Lot No. 1 S. 72 E. 95.3' to the beginning.
