KNOW ALL MEN BY THESE PRESENTS, That I, Corrie Burton

in the State aforesaid in consideration of the sum of One hundred and fifty Dollars, to me in hand paid at and before the sealing of these presents by

L. Jackson Green,

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

L. Jackson Green, all that piece, parcel or lot of land situate, lying and being in the County and State aforesaid, near the City of Greenville, known as part of the Sam Goodlett Property, described as follows:

Beginning at a point a little distance South of the Southern Railway and running; thence Eastward 153 feet to a street; thence with this Street Southward 172 feet to a point; thence Westward 153 feet with L.J. Greens line to another point; thence Northward 172 feet to the beginning corner containing 26316 sq. feet, more or less, this being the North end of the said Sam Goodlett place.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
