Campbell, his heirs and assigns, all that certain piece, parcel or lot of land situate, lying and being about two miles West of Greenville Court House, in Greenville Township, near Woodside Mills, and being designated lot No. two (2) in Block "A", on plat made by W.D. Neves Surveyor, dated Jan. 1910, and recorded in R.M.C. for Greenville County in Plat Book "A" page 75 and being a part of a tract of land conveyed to me the said J.M. Fortner by W.C. 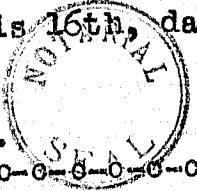
