

T.F. Simpson Deed TO Clarence E. Vaughan

STATE OF SOUTH CAROLINA, COUNTY OF Greenville

KNOW ALL MEN BY THESE PRESENTS, That I, T.F. Simpson, of Greenville County and

in the State aforesaid in consideration of the sum of Five hundred Dollars, to me in hand paid at and before the sealing of these presents by

Clarence E. Vaughan, of the County and State aforesaid (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said

Clarence E. Vaughan, All that certain piece, or parcel of land situated in Greenville County State of S.C. near the Monaghan Mill, being Lot No. 27 of a sub-division known as Morgan Hill having the following metes and bounds, to wit:

Beginning at the Northeast corner of the Brandon Road and Monaghan Street and running; thence with Monaghan Street North 82-3/4 East 226 feet to a stake; thence with line of No. 28 South 7-1/4 West 202 feet to Brandon Road; thence with Brandon Road South 13-3/4 West 64.36 feet to the beginning corner, being the same lot conveyed to me by J.A. Russell under date of Nov. 13, 1908 and recorded in the office of R.M.C. of Greenville County in Book 5, page 659.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said

Clarence E. Vaughan and his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said Clarence E. Vaughan, and his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
