KNOW ALL MEN BY THESE PRESENTS, That We, J.E. & J.H. Baldwin

in the State aforesaid for in consideration of the sum of Fifty Dollars to us in hand paid at and before the sealing of these presents by

E.S. Smith (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said E.S. Smith, all that piece, parcel or tract of land, situate, lying and being in the County & State aforesaid, on branches of Laurel Creek, branch waters of Reedy River, adjoining lands of Sam Vaughan, and E.S. Smith and others, and containing three and 65/100 acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said E.S. Smith, his heirs and assigns forever.

AND we do hereby bind ourselves, our heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said E.S. Smith, his

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
