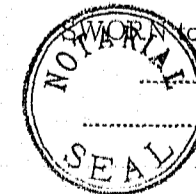


Mrs. T. E. Cresswell DEED TO W. R. Harper

 KNOW ALL MEN BY THESE PRESENTS, That I, Mrs. T. E. Cresswell of Palzer, State and County aforesaid in the State aforesaid in consideration of the sum of Sixteen hundred (1600.00) Dollars DOLLARS, to me in hand paid at and before the sealing of these presents by W. R. Harper (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W. R. Harper, all that certain piece, parcel or tract of land containing 32-1/4 Thirty-two and one quarter acres, more or less, situate, lying and being in Grove Township, Greenville County, State aforesaid, lying on the North side of the old Mill Road, and bounded on the East by lands of T. J. Harmon, and on the North by Cleveland's land, and on the West by the lands of Arch McMahan, and on South by the Old Mill Road, having the following metes and bounds to wit:  
 Beginning at stone X3 on old mill road; thence N. 2-1/4 E. 35.00 to a stone X3, along the aforesaid T. J. Hannon line; thence N. 43 W. 1.94 to a stone X3; thence S. 89-5/8 W. 4.95 to a stone X3; thence S. 11-1/4 W. 34.80 along the aforesaid Arch McMahan lands to a stone X3 in the aforesaid old mill road; thence up the old mill road N. 78 W. 8.23 to the beginning corner and is more clearly described by a plat made by Wm. F. Lee, Nov. 22nd, 1893, being a part of lots No. 3 & 6 in the division of the old Richardson Lands. The above described land being a part of the land deeded to me by W. P. 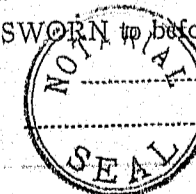

Adams (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said B. C. Adams, all that piece, parcel or lot of land in the State and County aforesaid near the City of Greenville, having the following metes and bounds, to-wit:  
 Beginning at an iron pin on Morgan St.; thence to N. 7-1/4 W. two hundred (200) feet to iron pin; thence N. 82-3/4 East sixty (60) feet to iron pin; thence S. 7-1/4 E. two hundred (200) feet to iron pin on Morgan St.; thence S. 82-3/4 W. sixty (60) feet with Morgan Street to beginning corner.
