is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said W. W. Storer, all that certain piece, parcel or lot of land situate, lying and being in the city of Greenville, State aforesaid, on the West side of the extension of West Washington Street and Walnut Street, said lot fronting on said extension of West Washington Street seven (7) feet and receding in a westerly direction with said Walnut Street one hundred and fifty (150) feet to an alley, being more fully described as lot 7016 Block "H" on plat of Cagle and Maudslow property, said plat made by J. E. Sirens Civil Engineer, July 21, 1905. This being the same lot of land conveyed to me by W. W. Storer Feb. 11, 1913.
