the receipt whereof is hereby acknowledged, HAVE GRANTED, bargained, sold and released, and by these Presents DO GRANT, bargain, sell and release unto the said J.D. Lanford, All that certain tract of land situate in Glassy Mountain

Township, County and State aforesaid, adjoining lands of T.H. Reid, and tracts Nos. 5, 11, 13, and 14, (and known as tract No. 12) in plat of survey of the lands of the estate of Geo. I. Cunningham, made by R.E. Dalton, Ass.
