KNOW ALL MEN BY THESE PRESENTS, That Judson Mills

a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of One Hundred Seventy Five DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released and by these presents does grant, bargain, sell and release unto

J. O. Heatherty his heirs and assigns All that piece parcel and lot of land situate in the State of South Carolina and County of Greenville as shown on the plat of the Judson Mills Company known as "Edgemont" and being designated on said plat as lot 1000. Said lot has a frontage on Piedmont Avenue of 65' 0" and a depth of 150' 0" to the property of Judson Mills as by reference to said plat will more fully appear. Said lot is recorded in Register of Deeds Conveyance Office for Greenville County in Plat Book "D" page 35.

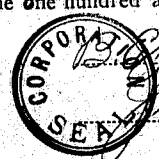
TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
