KNOW ALL MEN BY THESE PRESENTS, That I, Judith Boulware

in the State aforesaid

in consideration of the sum of Five hundred (\$500.00) DOLLARS,

to in hand paid at and before the sealing of these presents by

Trustees of Mountain View Congregational Church (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

Congregational Church, by John Heyward, M. J. Heyward, Duncan Dial, Letha Wilson and Judith Boulware as Trustees for said Mountain View Congregational Church to them and their successors in office and assigns forever, All that certain lot or parcel of land in said County and State on "New Cut Road" in Vicinity of Woodside Mill:

Beginning on said road and running thence S. 11-3/4 E. 135 ft. to stone corner & iron pin; thence S. 59-1/2 W. 50 ft. thence by straight to point in said line "New Cut Road" 50 ft. from beginning corner, and along said "New Cut Road" 50 ft. to beginning corner, being the site of what was formerly Mountain View Baptist Church.



TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said Mountain View Congregational Church by said Trustees and its and their successors and their heirs and assigns, forever.

AND I do hereby bind me & my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said Mountain View Congregational Church by said Trustees, its and their successors in office heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
