KNOW ALL MEN BY THESE PRESENTS, That I, W.H. Whitt of Greenville,
County of Greenville

in the State aforesaid
in consideration of the sum of Twelve hundred and no/100 DOLLARS,
to me in hand paid at and before the sealing of these presents by

W.M. Norwood (the receipt whereof
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

W.M. Norwood, All that piece, parcel or lot of land situate, lying and being in the County of
Greenville, State of South Carolina, and City of Greenville, on North side of Birnie Street
and having the following metes and bounds to wit: Beginning at a stake on said Street, corner
of lot number 20, thence along said Street 57-1/2 feet to a stake corner on said Street and an
Alley, thence along said Alley 28-1/2 E. 165 feet to a stake, thence N. 61-1/2 W. 57-1/2 feet to a
stake on line of said lot No. 20, thence with said lot No.20, S. 28-1/2 W. 165 feet to beginning
corner and said lot to contain 9487 square feet, more or less, adjoining lands of Sally Scott
and others, being the same conveyed to me by Thos. N. Scott on the 29th, day of May, 1909 and
recorded in R.M.C. Office June 1st, 1909 Book 4, page 374.

every person whomsoever lawfully claiming or to claim the same, or any part thereof.

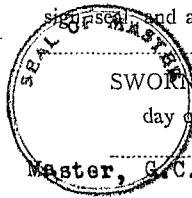
