KNOW ALL MEN BY THESE PRESENTS, That We, W.T. Henderson, T.F. Hunt and H.W. Hunt

in the State aforesaid in consideration of the sum of Two hundred and fifty dollars DOLLARS, to me in hand paid at and before the sealing of these presents by

J.P. Stover (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.P. Stover all that piece parcel or lot of land situate, lying and being in County of Greenville State aforesaid: Beginning at a stake two hundred and fifty feet from North west corner of O'Neal Street and McD Avenue, thence with McD Avenue in a Northerly direction fifty feet to a stake at joint corners of lots Nos. 129 and 130, thence with dividing line of lots Nos. 129 and 130 in a westerly direction one hundred and forty nine feet to a stake at corner of lots No. 129 and 130 and Hunt Street, thence with Hunt Street in a southerly direction fifty feet to a stake at corner of lots No. 130 and 131; thence with dividing line of lots Nos. 130 and 131 in an Easterly direction one hundred and fifty seven and one-half feet to the beginning corner, known as lot No. 130 according to map of City View property.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J.P. Stover, his heirs and assigns, forever.

AND we do hereby bind ourselves and our heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J.P. Stover, his

heirs and assigns, against us and our heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
