KNOW ALL MEN BY THESE PRESENTS, That I, E.P. Kuykendall, in the State aforesaid
in consideration of the sum of Twenty-five (\$25.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by R.N. Gallamore

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said R.N. Gallamore, All that lot or parcel of land in said County and State, Greenville Township, situate on the new Paris Mountain Road, and known as Lot No. 130 of the subdivision of the Hammett lands by W.S. Lee, on July 3, 1903 and being the same lot of land conveyed to me by W.G. Sirrine on February 2, 1911, by deed recorded in R.M.C. office Vol. 10, page 58, reference to same being hereby craved.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in any-wise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said R.N. Gallamore, his heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said R.N. Gallamore, his heirs and assigns, against myself and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
