in consideration of the sum of Twenty three hundred DOLLARS,

to me in hand paid at and before the sealing of these presents by J.M.H. Stover
is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said

J.M.H. Stover, All that piece, parcel and lot of land situate, lying and being in Gantt Township and County aforesaid, having the following metes and bounds, to wit:

Beginning at a stake on the White Horse Road; thence S. 58. E. 13 chains to a stone; thence N. 51-1/4 E. 17.87 to a stone; thence N. 77-1/4 W. 13 chains to a stone; thence S. 4-1/4 W. 17.87 to the beginning corner, containing twenty three (23) acres, more or less, plat made by Jno. M. Cureton, June 3rd 1908 and being the tract of land purchased of Jos. A. McCullough and conveyed to Jos. A. McCullough by Susan N. Simpson by deed bearing date of June 28th, 1908 and recorded in R.M.C. office Book ZZZ page 51. This same piece, parcel and lot of land deed to W.G.
