a corporation chartered under the laws of the State of *South Carolina* and having its principal place of business at *Greenville, County* in the State of *South Carolina* for and in consideration of the sum of *Four Hundred (\$400.00)* DOLLARS, to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto *Thomas E. Coker, W. P. Rogers, and W. A. Ross, as Trustees of Fork Shoals Public School, District No. 2-B.*

all that certain lot of land in Oak Lawn Township, County and State aforesaid, lying on the south side of the Public Road, and bounded by lands of W. A. Ross and Katrine Manufacturing Company, and having the following metes and lines, to wit: - Beginning at an iron pin in the public road, W. A. Ross's corner, and running thence with Ross's line S. 19-45 E. 8.31 chains to iron pin; thence with Ross's line N. 66-30 E. 4.31 chains to iron pin in line of Katrine Manufacturing Company; thence with line of said Katrine Manufacturing Company N. 19-45 W. 8.38 chains to an iron pin in the public road; thence with said road S. 66-30 W. 4.31 chains to the beginning pin, containing four (4) acres, more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee... hereinafter named, and *their successors* and assigns forever.

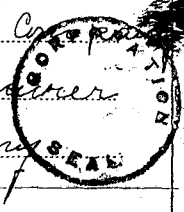
