a corporation chartered under the laws of the State of South Carolina and having its principal place of business at Greenville in the State of South Carolina for and in consideration of the sum of Ten dollars and other valuable consideration to it in hand duly paid at and before the sealing and delivery of these presents by the grantee... hereinafter named, (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

W.N. McCall, All that cert@ in piece, parcel or tract of land in Greenville Township, Greenville County, South Carolina, near the Judson Mills, being known as lot No. 80 on plat of property of Pride & Patton Land Company recorded in R.M.C. Office for Greenville County in Plat Book E., page 249, fronting 57 feet on the South side of Goodrich Street with a depth in parallel lines 203.5 feet along its eastern side and along its western side of 198.6 feet and being 50.24 feet wide at rear. Being a portion of the same conveyed to Pride & Patton Land Company by Judson Mill by deed dated May 15, 1920, recorded in Book 53, page 402.
