is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

D.P. Cox, All that piece, parcel and tract of land situate, lying and being in Austin Township
State and County aforesaid, part of T. Manning Cox place, Beginning at an iron pin on E. F.-
Griffin's line, thence S. 47 E. 6.40 ch. to iron pin in road, thence S. 42-1/2 E. 5.64 ch.
to iron pin, corner in road, thence S. 47 E. 9.20 ch. to a persimmon stump, corner of Lewis-
Spillers land, thence S. 25-1/2 W. 42.00 ch. to a pine stump, corner of Geo. Thompsons and Lewis-
Spillers' land, thence N. 48 W. 23 ch. to an iron pin on corner of Geo. Thompson's land and
