KNOW ALL MEN BY THESE PRESENTS, That I, J.B. Prewette, of Campobello, S.C.,
R.F.D. No. 3, in the State aforesaid
in consideration of the sum of Five hundred and seventy-five (\$575.00) DOLLARS,
to me in hand paid at and before the sealing of these presents by

T.E. Morrow, of Campobello, R.F.D. No. 2 in the State aforesaid (the receipt whereof
is hereby acknowledged), have Granted, Bargain, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

T.E. Morrow, All that certain lot, piece or parcel of land situated in County and State afore-
said, Highland Township and on South side road leading from McClain bridge to Five Forks-
Beginning on a stone in line of McClain land and runs thence S. 35-1/4 W. 9.26 chains to a stone
in ravine, T.B. Bartons corner; thence with Bartons line S. 16 E. 6.58 chs. to a stone in
field; thence with Bartons line S. 86° 10' E. 9.55 chs. to a stone (new corner) in Bartons
line; thence N. 1° E. 15.04 to an iron pin in said road leading to Five Forks, also stone
set on S. side said road; thence with said road S. 79-3/4 W. 4.25 chs. to bend in road; thence
N. 83-3/4 W. 2.08 chs. to the beginning corner and contains 13-3/4 as per survey of J.H.-
Atkins Mch. 3rd, 1915.
