Ross, All that piece, parcel and tract of land situate in State and County aforesaid O'Neal Township, on the waters of Dry Branch and Clear Creek, which is a tributary of the South Tyger River, and adjoining lands of J.W. Ross, T.B. Powell, Tim Barbare, and myself, and being part of the same land conveyed to Mrs. Laura R. Williams by Lewis H. Fleming, Dec. 10th, 1888, and recorded in the office of Register of Meane and Conveyance of said County in Book E, page 131, and having the following metes and bounds viz: Beginning on an iron pin 3x, which is the 3x of J.W.
