to *me* in hand paid at and before the sealing of these presents by *C. D. Robbins* (the receipt whereof  
is hereby acknowledged) have Granted, Bargained, Sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the  
said *C. D. Robbins*

All that lot of land situate in the County and State  
aforesaid, having the following metes and bounds: Being  
on the north side of Emma Street, near the town of Green  
and known as lot no 78 and lot no 79 on a plat of land  
known as *Morrow Park* and recorded in the *R. M. C.*  
Office in and for said County of *Greenville* in plat book "E"  
page 91 and is the same lots of land conveyed to me by  
*C. Chandler* in deed bearing date *Apr. 12th, 1918*.
