KNOW ALL MEN BY THESE PRESENTS, That I, Helen B. McDaniel of Greenville County in the State aforesaid in consideration of the sum of Ninety-five and no/100 DOLLARS, to me in hand paid at and before the sealing of these presents by Henrietta Anderson and James Anderson (the receipt whereof is hereby acknowledged), have Granted, Bargained, sold and Released and by these presents do Grant, Bargain, Sell and Release, unto the said

Henrietta Anderson and James Anderson, their heirs and assigns, All that certain piece, parcel or lot of land situate lying, and being in the State of South Carolina and County of Greenville and in Greenville Township in the 2nd. Ward of Greenville City on Hill Street and having the following metes and bounds, according to a plat made by R.E. Dalton, July 1911 of Peegan and Moseley sub-division of Richland Creek lands. Said plat is recorded in plat book A., at page 145, to-wit: Beginning at a stake on the south side of Hill Street, at corner of lot #65 and running thence N. 77-30 W. along Hill Street 32 ft. to a stake, corner of lot #67; thence S. 11 W. 119.6 Ft. to a stake; thence S. 78-30 E. 32 feet to a stake; thence N. 11 E. 119.2 feet to the beginning corner, bounded by lots #65 and 67, Hill Street.
