KNOW ALL MEN BY THESE PRESENTS, That J. James Pickett, of Greenville  
County

to me in hand paid  
at and before the sealing of these presents by R. M. DeShazo

is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said R.M. DeShazo, all and singular, All that piece, parcel or lot of land situated, lying and being in Greenville County, Gantt Township, State of South Carolina, about seven miles from Greenville Court House; Beginning at a stone 3XNM in the White Horse Road; thence North 82 East 13.10 to a stone 3XNM on Vaughan's line; thence North 44 West 2.50 to a stone 3XNM; thence North 3.50 East 12.24 to stone on road 3XOM; thence with said road North 82-1/2 West 1.85 to a bend in said road; thence North 63 West 7.39 with said road to a stone 3XNM; thence south 29 West 5.00 to a stone 3XNM; thence North 63 West 4.00 to a stone 3XNM; thence South 29 West 4.00 to a stone in White Horse Road 3XNM; thence with said Road to the beginning corner, containing 21 acres, more or less, being the same land conveyed to W.G.-Sirrinc by A.E. Howard by deed recorded in R.M.C. office for Greenville County in Volume 3, page 296.

Also all that other piece, parcel or lot of land adjoining the above in the State and County aforesaid, on the Paper Mill road, having the following metes and bounds: Beginning at a point on the south side of the Paper Mill Road at the corner of Mack Pages' land and another lot owned by me; thence South 29 West 5.00 to a stone; thence South 72 East 4.14 to a stone; thence North 79-1/2 East 8.00 to Paper Mill Road; thence along said road North 64 West 7.00 to the beginning, containing two and one-tenth acres, more or less.

Also all that other tract of land in the County and State aforesaid, adjoining the last above described lot: Beginning at a point at the north west corner of the lot above described on the Paper Mill Road; thence N. 64 W. along said road 4.00; thence S. 29 W. 5.00 to a stone; thence S. 63 E. 4.00 to a stone at western corner of the lot above described; thence N. 29 E. 5.00 to a point on the Paper Mill Road, the beginning corner, containing two acres, more or less. Said two tracts were conveyed to me (James Pickett) by Ida Charles, September 27, 1910 deed recorded in Book 3, page 320.
