by acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release, unto the said H.P. McGee, William Goldsmith and B. E. Geer. All those two certain lots of land situate in the First Ward of the City of Greenville, County of Greenville and State of South Carolina, more particularly described as follows:- (1) All that certain lot of land, BEGINNING at an iron pin on the North-West corner of Buncombe and Parker Streets, and running thence with Parker Street N. 46-30 E. one hundred sixty-four and thirty-six-hundredths (164.36) feet to an iron pin; thence N. 34-30 W. fifty-five and ten-hundredths (55.10) feet to a fence post; thence S. 51 W. one hundred sixty two and seven-tenths (162.7) feet to a fence post on Buncombe Street; thence with Buncombe Street S. 34-30 E. sixty-six and six-tenths (66.6) feet to the beginning corner.
