(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

B. W. Grace, all that certain lot of land situate  
at Paris, in the State and County aforesaid, more  
particularly described as follows:—

Beginning at a point (on line between Mauldin  
lot and the lot conveyed to me by Realty Cor-  
poration) 91.8 feet from the East side of moon-
