(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

S. B. Song, all that certain piece, parcel or lot of land situate, lying and being in the State and County aforesaid and having the following metes and bounds, to wit:—Beginning at a stone in bed of branch where W. A. Hammett's corner and runs thence 87 1/2 E. 3.75 to a stone; thence N. 17 E. 16.20 to a stone; thence N. 88 1/2 W. 1.20 to a small maple on said branch; thence down the meanders of said branch about 17 chains to the beginning corner. Being the same piece of land deeded to W. J. Edwards and A. E. Bowman by S. Augustus Green by deed dated August, 21st. 1914.
