NOW, KNOW ALL MEN BY THESE PRESENTS, That I Emma Bridges of Greenville County in the State aforesaid in consideration of the sum of Three Hundred DOLLARS, to me in hand paid at and before the sealing of these presents by L. S. Poole

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said L. S. Poole, all that piece, parcel and tract of land lying, situate and being in the State and County aforesaid and Bates Township, known as a part of the land conveyed to me by deed from Pauline Curtis and Lot no. 13, adjoining land of myself and L. S. Poole. Beginning on a stone on the mill road thence running with said Road N. 86 W. 8.58 to a stake, thence S 9 E 4.40 to a stake, thence S 85 E 7.50 to a stake, thence N 3 W 9.35 to the beginning corner and contains Seven and a half (7 1/2) acres the same more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said L. S. Poole, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said L. S. Poole, his heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
