 in consideration of the sum of Two Hundred Eighty Five (\$285) DOLLARS,  
 to me in hand paid at and before the sealing of these presents by  
Ewart Moore

(the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
Ewart Moore, all that piece, parcel, tract, gland  
 situate lying and being in the State and County aforesaid  
 and bounded waters of S. Tiger River and the Rural  
Township, and has the following metes and bounds  
 to wit: Beginning at a stone corner, the C. C. Phillis  
place and on W. L. Westmorelands line, thence N. 18 E. 10.26  
chs. to ranch; thence up and with the meanderings of  
 ranch as a line, 12.26 chs. to a stake in ranch; thence  
S. 60 3/4 E. 8.90 chs. to the beginning corner containing four  
(4 3/4) and three fourths acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.  
 TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said
