in consideration of the sum of \$900 nine hundred DOLLARS,
to me in hand paid at and before the sealing of these presents by P. F. Lindsey

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said

P. F. Lindsey, all that piece, parcel or tract of land situated lying and being in the State and County aforesaid on the head water of Morgans Creek waters of North Pacolet and in Glassy mt'n Township, containing two (200) hundred acres, with twenty five or thirty excepted adjoining lands of Arthur Howard on the South Joshua Lindsey on the East Jas and Jeff Howard on the north, and on the west by lands of Rachel Lindsey and Susan and Malinda Howard for further particulars see plat made by J. D. Norman Sept 18, 1889, said plat covers about two hundred acres which is conveyed by this deed and twenty five or thirty acres conveyed to Rachel Lindsey and Malinda Howard about 1904.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said P. F. Lindsey his heirs and assigns, forever,

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said P. F. Lindsey and

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
