NOW, KNOW ALL MEN BY THESE PRESENTS, That I, R. E. Chandler of Greenville
County in the State aforesaid,
in consideration of the sum of Ten Dollars and other Valuable Consideration DOLLARS,
to me in hand paid at and before the sealing of these presents by

M. E. Jones

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
M. E. Jones, all of my undivided one-tenth interest in
all that piece, parcel or tract of land situate, lying and
being in Butler Township, in the County and State
aforesaid about five and one-half miles from the
City of Greenville, containing twenty acres more or
less, and adjoining lands of Perry Hudson, D. A. Green,
and others, and known as the Francis Chandler place.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.
TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said M. E. Jones his
heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and
forever defend, all and singular, the said premises unto the said M. E. Jones his

heirs and assigns, against me and my heirs, and against
every person whomsoever lawfully claiming or to claim the same, or any part thereof.
