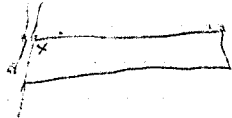


J. C. Milford DEED TO Mary B. Foster

 (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said
Mary B. Foster and her heirs, All that certain lot or parcel
 of land situate in the County of Greenville, State of South Carolina
 and fronting on the West side of Augusta Street five feet with
 a depth Two Hundred feet, being on the South side of Mrs.
Mary B. Foster's house & lots, also all of that certain lot or parcel
 of land situate in County of Greenville, State of South Carolina &
 fronting on Burns St. in the rear of Mrs. Foster's house & lots
 and has the following courses and distances, Commencing
 at iron on Burns St. thence N. 14 E. 71.5 (Seventy one & half
 feet) to iron at Geo. Browne's Corner, thence N. 78.30 E. 137.5
 One Hundred & Thirty seven & half feet to iron, thence S. 12.56
 E. Sixty five feet to iron, thence S. 78.30 W. one hundred &
 sixty five feet to the beginning corner, Surveyed by A. D.
