 (NOW, KNOW ALL MEN BY THESE PRESENTS, That I Mrs. H. E. Ollis of the County of Greenville in the State aforesaid, in consideration of the sum of Ten dollars & other good & valuable considerations (\$10.00) DOLLARS, to me in hand paid at and before the sealing of these presents by J Lee Greene

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said J Lee Greene:- All that certain piece parcel or tract of land, situate lying and being in the County of Greenville, State of South Carolina, and having the following metes and bounds to wit: Beginning at a pine, and running thence S 57 3/4 W. 8.85 to a stone; thence S 27 1/3 W. 5.00 to a stake; thence S 44 E. 6.10 to a stake; thence S 47 4 E 7.75 to an iron pin; thence N. 44 1/2 E. 4.35 to a stake; thence N. 44 1/4 E. 20.15 to an iron pin; thence N. 44 1/2 W. 13.25 to an iron pin; thence S 44 1/4 W. 11.50 to the beginning corner, and containing 33 acres more or less, and being tract no 4 of the Emily M. Cole land as shown in plat book 6 at page 157, and being the same tract of land conveyed to me by Mary Abigail M^{rs} Connell. 4/4/22

As a part of the consideration hereinabove expressed the grantee herein is to assume and pay note and mortgage given by me to Mary Abigail M^{rs} Connell for \$2000.00. This is expressly understood and agreed that the present crop now growing on the above described land and all wood now cut is hereby expressly reserved to the use of the herein named grantor. It is also agreed and understood that the said grantor shall have the right of ingress, regress and egress for the purpose of removing said crops and said wood.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the said premises before mentioned unto the said J Lee Greene, his heirs and assigns, forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said J Lee Greene, his

heirs and assigns, against me and my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
