*of Greenville* in the State aforesaid,  
 in consideration of the sum of *One (\$1.00) Dollar and other valuable consideration*  
 to *me* in hand paid at and before the sealing of these presents by

*Pauline C. Gurganus*  
 (the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these Presents do Grant, Bargain, Sell and Release unto the said  
*Pauline C. Gurganus*, her heirs and assigns forever. All that  
 certain piece or parcel or lot of land situate, lying and being  
 in the State and County aforesaid and in the City of *Greenville*,  
 in *Pauline C. Gurganus* and *John W. Norwood*, and  
 having the following metes and bounds, to-wit: Beginning  
 at a corner on *M. Daniel Avenue*, corner of property now or  
 formerly owned by *Walter S. Manly* and two hundred and  
 seventy five and two thirds ( $275\frac{2}{3}$ ) feet south from  
*Cleveland Street* and running along line of the *Walter S. Manly*  
 property S. 85 E. three hundred and thirty  
 feet ( $330$ ) to a corner on a proposed new street  
 thence along proposed new street S. 3 N. seventy five  
 feet ( $75$ ) to a corner on *M. Daniel Avenue* North  
 and thirty feet ( $30$ ), to a corner on *M. Daniel*
