 (the receipt whereof is hereby acknowledged) have Granted, Bargained, Sold and Released and by these Presents do Grant, Bargain, Sell and Release, unto
 the said _____

all that piece, parcel or lot of land in Austin
 Township, Greenville County, State of South Carolina
 about one mile from Coblesville Mills, near the
 road to Mauldin, being a part of a tract con-
 veyed to J. D. White by G. D. Donaldson, adjoining
 lands of J. D. White, C. C. White and Rhoda L.
 Foster, and bounded as follows: Beginning on a
 rock, thence S. 84 1/2 W. 3.98 to a B. Q. thence S. 21 1/4
