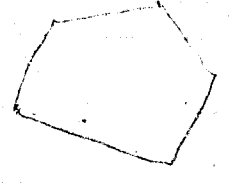


*J. P. Hillis* DEED TO *J. H. Hill*

KNOW ALL MEN BY THESE PRESENTS, That *J. P. Hillis of Greenville*

in consideration of the sum of  
*Twenty Seven and Fourteen and 85/100* DOLLARS,

at and before the sealing of these presents by *J. H. Hill*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said  
J.W. Hill, All that tract or parcel of land being, lying and situated Fairview Township of Greenville County and State aforesaid. The same being a tract of land conveyed to me by B.E. and J.M. Geer President and Sec. and Treas. of Cedar Falls Light and Power Co., on the 31st day of December 1917 with the following metes and bounds to-wit:  
Beginning on Cedar stake on east bank of Reedy River and thence running N. 6 E. 32.50 to a stake on line of tract No. 9; thence with line of said tract N. 80 E. 6.00 to oak 3X corner of tracts No. 9 and 10; thence with line of tract No. 10, S. 64 E. 16.70 to stone thence S. 27-1/2 W. 17.25 to stone; thence S. 54 W. 17.81 to beginning corner, containing Forty-two and 9/10 (42.90) more or less, known as lot No. 11 of the Katrine Mfg. Co., property, see plat made by F.C. Rodgers, Surveyor Dec. 1916.  
Also, all that other piece or parcel or tract of land situate, lying and being in County and State aforesaid and having the following metes and bounds, to-wit:  
Beginning at cedar stake on east bank of Reedy River corner of corner of lot No. 11; thence running with said line N. 6 E. 32.50 in line of tract No. 9; thence with said tract S 80 W. 9.00 to stone on bank of said river; thence with river as line in southerly direction to 3.00 to stake; thence S. 55 E. 3.00 to oak 3X S. 36-1/2 W. 7.00 to stone S. 11 W. 2.56 to cedar; thence S 67 W. 4.80 to stake on east bank of River; thence with River as a line 22.50 in southeasterly direction to beginning corner, containing (28) twenty-eight and (47/100) acres, more or less, and known as Tract No. 12 on plat above referred to.
