

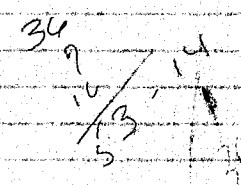
O. A. Moore DEED TO *L. H. Littlefield*

KNOW ALL MEN BY THESE PRESENTS, That *O. A. Moore*

in the State aforesaid,
in consideration of the sum of
Five Thousand DOLLARS,
to *me* in hand paid
at and before the sealing of these presents by *L. H. Littlefield*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *L. H. Littlefield*; All that piece, parcel or lot of land in the County and State aforesaid, having the following metes and bounds to wit: Beginning at a stone on the *Mostella Road* and runs thence *S 88 1/4 E*, 31.06 chains to a stone; thence *N 5 E*, 15.10 chains to a stone; thence *N 86 1/2 W*, 31.92 chains to a stone on the said *Mostella Road*; thence with said road *15.94* chs. to beginning corner, containing *Thirty Six (36)* Acres, more or less.

Also all that other piece, parcel or tract of land situate as aforesaid, having the following metes and bounds to wit: Beginning at a corner in *Mostella road* and runs thence with said road *14.35* chains to a stone; thence *S 89 1/4 E*, 22.00 chs. to a stone; thence *S 8 E*, 14.35 chains to a stone; thence *N 61 1/4 E*, 8.20 chains to a pin; thence *N 88 W*, 2.00 chains to beginning corner, and containing *Seven (7)* Acres more or less.

Also all that other piece, parcel or tract of land situate as aforesaid, having the following metes and bounds to wit: Beginning on an iron pin *3x 3/4 in* in the *Mostella Road* and runs thence *N 62 1/4 E*, 18.90 chains to a *Post Oak 3x 3/4 in*; thence *S 18 1/2 E*, 10.85 chains to a stone *3x 3/4 in*; thence *N 86 1/4 W*, 20.60 chains to the beginning corner, containing *Ten and three tenths (10 3/10)* acres, more or less.
