(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, Sell and Release unto the said *Bessie Switzer, her* ~~and assigns, All~~

that certain piece parcel or lot of land situate lying and being in the State of South Carolina, in the City and County of Greenville, and having the following metes and bounds according to a plat made by *A. S. Bump*, dated *Sept. 23, 1911*, beginning at an iron pin on the South side of a thirty foot street (known as Central Ave) running west from *Townes St.* and 150 feet from *Townes St.* running thence *N. 66 W. 44* feet along the South line of said 30 ft. street (Central Ave) to an iron pin, thence *S. 23 1/2 W. 150* feet, to an iron pin thence *S. 66 E. 54* feet to an iron pin thence *N. 16 E. 150* feet to beginning corner and being the Eastern portion of a lot of land conveyed to me by *J.
