in the State aforesaid, in consideration of the sum of One DOLLARS, to R. H. Eppel in hand paid at and before the sealing of these presents by R. H. Eppel

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said R. H. Eppel all that certain piece of land containing 11 acres, more or less, in Dumplin Township known as lot no. 3 of the lands of Sarah A. Eppel Jordan and described as follows: Beginning at a stake on the Cooper line thence N. 53 1/4 E. 9.07 to rock, thence N. 46 1/2 W. 12.40 to stake on Coaley's line, thence S. 53 1/4 W. 8.90 to a stake, thence S. 46 E. 12.44 to the beginning corner. A right of way for a road on the line of lots no. 1, 2, and 5 from lot no. 3 to the Pulzer road is reserved.
