Satisfaction of the claim of the Board of Trustees of Chicora College against me for the purchase money of the land therein described, and the sum of one dollar 20 cents, in hand paid at and before the sealing of these presents by the Board of Trustees of Chicora College, in the State aforesaid

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

Board of Trustees of Chicora College all those certain parcels and lots of land situate lying and being in the City of Greenville, County and State aforesaid, being a part of the property formerly owned by the said Board of Trustees of Chicora College and conveyed to me by said Board of Trustees by Deed dated October 25th, 1915, recorded December 30, 1915, in R.M.C. office in and for the County of Greenville in Book of Deeds 25 page 107; said lots being known as lot fourteen (14) and fifteen (15) on plat of Chicora College property made by H. Olin Jones, Architect and Engineer, said plat being recorded in R.M.C. office Greenville County, in Plat Book C, page 265; said lots fourteen (14) and fifteen (15) fronting twenty five (25) feet each on Main Street and running back in parallel lines one hundred (100) feet to a ten foot alley.

Office for Greenville County, Plat Book C., page 265 and being the same lots conveyed to J.M. Fortner by the Board of Trustees of Chicora College by deed dated October 25th, 1915 and recorded Vol. 25, page 107 R.M.C. Office for Greenville County.

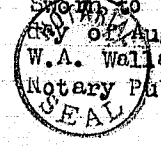
