

Noah Russell DEED TO P. F. Ward

KNOW ALL MEN BY THESE PRESENTS, That A. Noah Russell

in the State aforesaid, in consideration of the sum of DOLLARS, to me in hand paid at and before the sealing of these presents by P. F. Ward

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

P. F. Ward his heirs and assigns, Two tracts of land in Saluda Township County and State aforesaid, Tract no. 1 lying on head waters of Fall Creek and runs as follows; beginning on a red oak corner of John Ward's land thence N. 79 E. 250 chains to a white oak thence N. 15 E. 350 chains to a maple, thence E. 44 W. 11.75 chains to a Hickory, thence a conditional line to a maple from maple to a stake, thence with Davis line to a stone 37 on Jim Loggins line, thence with said Coggin line to saw ash thence S. 87 W. 7.25 chns. to a small hickory at ledge of rocks thence along ledge of said rocks 17.64 chns. to a chestnut David Paces corner on old road, thence along said road S. 32 E. 6.92 chns. to a turn in road, thence S. 8 E. 2.10 chns. to a branch running with said branch back to old line thence with old line to beginning corner containing 90 acres more or less. Bounded by lands of John Ward, Lewis Loggins and others. Tract no. 2 conveyed to W. E. Ward by James Coggin on the 10th day of February 1899 and to me by W. E. Ward on the 3rd day of September 1917 and runs as follows: Beginning on a chestnut oak corner on top of hill on J. L. Statons line and is also a corner of L. L. Davis line and runs with said Statons line to a poplar corner and thence with A. R. Statons land to a rock corner on top of a mountain near the N. C. line, thence with said A. R. Statons line to a black gum which is also a corner of Wm. Bradley's land, thence with said Bradley's land to a maple corner on a ledge of rock, thence with my line on tract #1 to a chestnut oak corner Perry Davis corner, thence with Perry Davis land to a Locust, thence on a ridge L. L. Davis line to the beginning corner, bounded by lands of J. L. Staton, A. R. Staton and others containing thirty (30) acres more or less.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging, or in anywise incident or appertaining, TO HAVE AND TO HOLD, all and singular, the said premises before mentioned, unto the said P. F. Ward, his heirs and assigns, forever.

AND myself, my heirs, executors and administrators, to warrant and forever defend, all and singular, the said premises unto the said P. F. Ward, his heirs and assigns, against me my heirs, and against every person whomsoever lawfully claiming or to claim the same, or any part thereof.
