 to *me* in hand paid
 and before the sealing of these presents by *F. L. Tindal*

(the receipt whereof is hereby acknowledged), have Granted, Bargained, Sold and Released, and by these presents do Grant, Bargain, sell and Release unto the said

F. L. Tindal, his heirs and assigns. - All that certain lot of land situate in the City and County of Greenville, South Carolina, fronting the south side of Grove Street and beginning at a point on said street fifty feet from the intersection of a forty foot street to be called Jackson Street, and running thence along Grove Street fifty feet to corner of lot No. 12; thence along the line of lots 13 and 25 to a point one hundred and fifty feet from Grove Street; thence in a line parallel to Grove Street; fifty feet to line of lot No. 27; thence along the lines of lots 12, 7 and 14; One hundred and fifty feet to Grove Street - the beginning corner. Being the whole of lot No. 13 and a part of lot No. 27 as shown on plat recorded in Plat Book A page 225, and being a part of the land conveyed to Nona J. Johnson by C. H. Mallard by deed bearing date Feb. 10-1913 and recorded in Vol. 24, page 311, and conveyed to Nina Bell Johnson by the said Nona J. Johnson by deed bearing date Feb. 14, 1913.
