State aforesaid, and both being portions of a tract of land con-
taining one hundred and six acres, more or less, conveyed
to me by T. T. Cox, by his deed bearing date January 7th 1918 and
recorded in R. M. C. Office for Greenville County, in Vol. 43, p. 304.
This land was resurveyed by R. E. Dalton, Engineers, and divided
into lots, and a plat made for the same, on the day of March, 1919.
These 2 lots were laid down on said map or plat, and num-
bered respectively 2 & 3; No. 2 containing 10.30 acres, and No. 3
containing 2.20 acres; Reference to said plat is herein made
as part of the description of said land for a better description
thereof.
