W. T. Lindsay and his heirs and assigns forever, the following described real-estate: "All  
that certain tract of land situate in Glassy Mountain and Saluda Townships, in Greenville  
County, and State of South Carolina, on North Saluda River and containing 92 <sup>1</sup>/<sub>2</sub> acres, more  
or less, and being the land of which C. A. Gosnell was seized and possessed at the time of his  
death".
