That the grantor reserves the right to place or authorize the placing of electric; telephone or telegraph poles, water pipes, or any other work of utility in or along any of the roadways,

Streets, or the back line of any lot without compensation to lot owner. Together with all and singular the rights, members, hereditaments and appurtenances to the said

premises belonging or in anywise incident or appertaining.
