WHEREAS, Priscilla Owens

on or about the 3rd day of October in the year of our Lord nineteen hundred and twenty-two exhibited her complaint in the Court of Common Pleas, for the County aforesaid, against Mary W. Campbell, et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 1st day of February 1923, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman

Master in and for the County aforesaid, to Priscilla Owens for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. 9709)

NOW, Therefore, Know all Men by these Presents, that E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said Priscilla Owens,

All that certain piece, parcel or lot of land situate lying and being in the City and County of Greenville, State aforesaid, and divided as follows;

Beginning at a point on the south wall of the present Casino Theater which point is seventy feet east of Main Street and running thence in an easterly direction thirty feet, six inches to a point thence in a southerly direction fifty eight feet six inches to the Butt property thence in a westerly direction thirty feet six inches to the corner of the property belonging to the estate of Frank C. Owens thence in a northerly direction along the property line of the said Frank C. Owens estate property, fifty eight feet, six inches to the beginning corner.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said Priscilla Owens, her heirs and assigns forever.
