TO ALL WHOM THESE PRESENTS SHALL COME:

I, E. Inman
Master in and for the County aforesaid, SEND GREETING:

WHEREAS, Phoenice A. Shockley as administratrix of the Estate of J. H. Shockley and in her own right, et al

on or about the 16th day of November in the year of our Lord nineteen hundred and twenty one exhibited their complaint in the Court of Common Pleas, for the County aforesaid, against Thelma Shockley et al

demanding relief as to the real estate described in the complaint: and the cause being at issue, came on to be heard on the 19th day of December 1921, and such proceedings were had therein as resulted in a decree of the said Court, whereby it was adjudged and decreed that the said real estate hereinafter mentioned and described, be conveyed by E. Inman Master in and for the County aforesaid, to J. W. Bridwell for the purposes mentioned in the said decree, as by reference thereto on file in said Court, will appear; (See Judgment Roll No. 4)

NOW, Therefore, Know all Men by these Presents, that I, E. Inman Master, in and for the County of Greenville aforesaid, by virtue of the aforesaid decree, and upon receipt of \$437.00 HAVE GRANTED, conveyed and released, and by these presents, DO GRANT, convey and release unto the said

J. W. Bridwell, his heirs and assigns forever, the following described real estate:
"All those certain pieces, parcels or lots of land situated in Chick Springs Township, County of Greenville, and State of South Carolina, and in the Town of Taylors, and being known and designated as Lots Nos. 5, 6, 9 and 10 on a subdivision of Lot No. 1, property of W.M. Shockley, Deceased, as shown by subdivision and plat of same made by Thos. T. Linder, Nov. 10, 1921, and recorded in the R.M.C. Office for the County and State aforesaid, in Plat Book F, at page 20. Lot No. 5, has a frontage of 27.7 feet on said National Highway and runs back in parallel lines 140.5 feet on one side and 142 feet on the other side and has a width in the rear of 28 feet; Lot No. 6 fronts 27.7 feet on said National Highway and runs back in parallel lines 142 feet on one side and 144 feet on the other, with rear line of 28 feet; Lot No. 9, fronts 27.7 feet on said National Highway and runs back in parallel line 151 feet on one side and 156 feet on the other, with rear line of 28 feet, and Lot No. 10 has 27.8 feet frontage on said National Highway and runs back in parallel line 156 feet on one side and 163 feet on the other, with rear line of 28 feet. The rear line of each of said lots extends along the right of way of the Southern Railroad".
Reference is hereby craved to the plat above referred to for a more particular description of said lots.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said Premises belonging, or in anywise incident or appertaining; and all the estate, right, title, claim and interest whatsoever of the parties to the cause aforesaid, and of each of them in and to the same; and of all other persons rightfully claiming from, under, or any of them.

TO HAVE AND TO HOLD, all and singular the premises before mentioned, unto the said J. W. Bridwell and his heirs and assigns forever.
