All that piece, parcel or lot of land in Greenville and in Greenville Township, Greenville County, State of South Carolina.

Lying on west side of North Main Street, and having the following metes and bounds, to wit: Beginning on West side of North Main Street in center of concrete culvert opposite the City Parks and running thence with North Main Street S 19 W 137 feet to a stake in a 12 foot alley; thence with said alley N 71 W 175 feet to a stake; thence N 14 E 132 feet along line parallel with Main St. to a point in line extending from Center of Main St. culvert to center of Pioneer St. culvert; thence in a straight line in an easterly direction 175 feet to the beginning, having situated thereon building known as Park View Apartments and being the same lot of land conveyed to me by W. (Reg. 16th, 1919 and recorded in Vol. 80, page 12, said unpaid portion (as of this date) of said mortgage being thirteen thousand and five hundred and no/100 (\$13,500.00) Dollars, said mortgage bearing interest at 6% per annum payable semi-annually. Also a mortgage of Five thousand and no/100 Dollars (\$5,000.00) executed Nov. 8th, 1919 by Thos. M. Walker & Co. Inc. which is recorded in Vol. 86, page 8. Also a mortgage of fifteen thousand and no/100 Dollars (\$15,000.00) executed Nov. 7th, 1919 by Thos. M. Walker & Co. Inc. which is recorded in Vol. - Page 10, said mortgage bearing interest at rate of 7% per annum payable semi-annually. Also a mortgage of Nineteen thousand and Eight hundred and no/100 Dollars (\$19,800.00) executed July 12th, 1921 by J. C. Harper which is recorded in Vol. 92, Page 147, said mortgage bearing interest at rate of 6% per annum payable annually.
