The above Right-of-way is for pole line (only) as now located on the property, and in the event that future developments of the Mills Mill plant should conflict with present location of said pole line, the Power Company will at its own expense relocate same on the property in a proper manner so as to conform to any street which they may lay out. The Power Company to pay all damage to crops caused by the maintenance of this line.
